

2019-20 access and participation plan monitoring

Provider impact report

This impact report summarises the progress made by South Devon College against targets, objectives and written commitments set out in its 2019-20 access and participation plan. This document is a summary of information submitted by the provider to the OfS. This document is a self-report by the provider only and does not indicate any OfS assessment of compliance.

1. Ambition and strategy

South Devon College's ambition and strategy as detailed in the 2019-20 access and participation plan:

Almost 90% of the South Devon College's higher education students come from at least one underrepresented group. Therefore, widening participation and access to higher education is our central mission and implicit in everything we do.

The overall ambition was to maintain the levels of access to higher education at the college for students from underrepresented groups, and improve the success outcomes and progression for underrepresented students, particularly those who are disabled. This ambition is reinforced and given greater clarity in our 2020/21-2024/25 access and participation plan.

As part of the College's recruitment and growth strategy there has been an increase in the provision of alternative Higher Education qualifications in the form of Higher and Degree apprenticeships, mainly in the field of health and nursing professionals. Direct-entry and apprentice students receive the same levels of support throughout the whole student journey.

Our evaluation strategy is overseen by the Equality, Diversity, Access and Participation Committee of the College's Governing Body. Our evaluations are based on students' narrative feedback, comparative analysis of the success of students who engaged in support compared to those who did not, pre/post analysis of interventions and activities, reports of student engagement with support services, and personal tutors' feedback.

To monitor the implementation of our access and participation activities, the college has regular engagement with the student population via the Student Course Representatives, Student Consultative Forum, Lead Student Rep, and student feedback surveys. This engagement is designed to ensure activities continue to meet the needs of students, is responsive to changes in learning community, and to shape future policy and activities.

Annex A: Commentary on progress against targets

South Devon College's commentary where progress against targets was less than expected.

Target reference number: T16a_04
How have you met the commitments in your plan related to this target?
44% of 2019/20 Level 5 FD students progressed onto L6 study. This is largely accounted for by the increase in healthcare programmes by higher apprenticeship programmes where L6 is not required for employment/progression.
Have you taken any additional steps other than that detailed in the plan to reach the selected milestone?
Our partner university has validated additional Level 6 programmes which started 2017/18 increasing the opportunities for local L6 study.

How have you met the commitments in your plan related to this target?
In 2019/20 according to our own internal destination of leavers of HE survey, 93.2% progressed into employment or further study, and 74.8% went into high skills.
Have you taken any additional steps other than that detailed in the plan to reach the selected milestone?
Further investment in employability resources and support, has established a strong focus on progression into employment in our tutorial curriculum, and new programme development.

The project did not proceed

Although we trained staff to facilitate the PASS project, there was little enthusiasm from the student body to act as PASS mentors. Covid also made it impossible to proceed with the project in 2019/20.

5 student participated in face-to-face workshops for the start of 19/20

Have you taken any additional steps other than that detailed in the plan to reach the selected milestone?

In response to Covid, in 19/20 for a 20/21 start, our pre-entry workshops went online with limited in-person workshops immediately before enrolment. The expansion of online resources was well received and reported positively however with the rapid move to online an evaluation strategy including engagement was not in place.
